

Schedule 1 – Areas where freedom camping is prohibited

Clause 7

<p>Explanatory notes</p> <p>Freedom camping on reserves is prohibited under section 44 of the Reserves Act 1977 and therefore prohibited under section 10 of the Freedom Camping Act 2011, except where it is permitted in the designated places on reserves specified in Schedule 2, which are subject to the restrictions in this bylaw. Some reserves where freedom camping is prohibited are included in this Schedule (and in the maps in Schedule 3), but not all.
